WITHDRAWAL & REFUND OF PARTICIPATION FEE 3 Applicant may please note that after allotment of booth, withdrawal will not be allowed and the amount deposited along with application will be forfeited. However, Part-Refund of participation fee will be considered in case where: The participant after approval withdraws from the participation but space is subsequently let out to some other participant who pays for the space. In such cases the first party can be allowed the refund after deducting 10%
